



- Four (4) inch solid white line
 - o If there is no existing parking lane stripe, use the "L" and "T" shaped markings extending to seven (7) feet off curb.
 - o If there is an existing parking lane stripe, use only lateral lines extending to meet the existing longitudinal parking lane stripe.
- Message and letters must be two (2) feet letter height using the SHSM standard alphabet. (https://mutcd.fhwa.dot.gov/ser-shs_millennium.htm)
 - o On center at 3.5 feet off curb, even if the existing parking lane is wider.
 - May reduce "Carshare" to twenty (20) inches if overextending within seven (7) feet of parking lane stripe.








TYPICAL PAVEMENT MARKINGS ARROWS & SYMBOLS






Single Lane School Message

 3. All messages consisting of two words or more shall have 8' between words and be laid out such that the first word is closest to an approaching vehicle. Spacing of 3' between words is typical of messages in bike lanes.

 4. Spacing between each letter shall be equal for any word. Letter spacing shall be 8" unless otherwise specified or as limited by lane width. All messages shall fit within a single lane and not overlap any striping, unless otherwise specified.








RAILROAD GRADE CROSSING NOTES:

- R1. WHERE THERE IS NO RAILROAD CROSSING GATE, THE CLEARANCE LINE SHOULD BE PERPENDICULAR TO THE ROADWAY, AND 15'-O" FROM THE NEAREST RAIL AT ITS CLOSEST POINT. WHERE THERE IS A GATE, THE CLEARANCE LINE SHOULD BE PARALLEL TO THE GATE IN ITS LOWERED POSITION, AND EITHER 15'-O" FROM THE NEAREST RAIL OR 8'-O" FROM THE GATE, WHICHEVER PLACES THE LINE FURTHER FROM THE CROSSING.

IF A W3-1 OR W3-2 SIGN IS REQUIRED IN ADVANCE OF A GRADE CROSSING, IT SHALL BE LOCATED IN ACCORDANCE WITH TABLE NY2C-4 AND THE W10-1 SIGN SHALL BE LOCATED APPROXIMATELY 200'-0" IN ADVANCE OF THE W3-1 OR W3-2 SIGN
- R5. A PORTION OF THE "RXR" MARKING MUST BE OPPOSITE THE W10-1 SIGN. 24" WHITE CROSS BARS ARE PLACED IN RELATION TO "RXR" MARKING. THE DISTANCE TO CLEARANCE LINE WILL VARY.
- R6. NORMAL SOLID DOUBLE YELLOW LINE TO BEGIN A MINIMUM OF 10'-0" UPSTREAM OF FIRST 24" WHITE CROSS BAR.


